Involvement of Parents in the Title I Program

To involve parents of the targeted students in the Title I program, at CJHS, the following practices have been established:

- The school convenes an annual meeting to inform the parents of targeted Title I designation, about the Title I program, and about the right for parents to be involved in the Title I program.
- There will be an annual Title I meeting held. Title I information will also be introduced at the SSC meetings held throughout the year.
- The annual Title I meeting will be held after school for family convenience.
- The school provides all parents of targeted students, information in a timely manner about the Title I program.
- Parents are involved through the regular communication at SSC meetings, held throughout the school year, on the school website, hard copies of information sent home to targeted Title I students, School Loop, school newsletters, the automated phone system, and the marquee in front of the school.

- The school provides parents of the targeted Title I students, an explanation of the curriculum used, the assessments used to measure student progress, and the proficiency levels students are expected to meet. This information is shared at the annual targeted Title I parent meeting and during the targeted Title I parent sessions of the Parent Institute of Quality Education (PIQE) meetings.
- An explanation of the curriculum used at the school, the assessments used to measure student progress, and the proficiency levels targeted Title I students are expected to meet are included on the school website, on the website of California Assessment of Student
 Performance and Progress (CAASP) assessment reports, English Language Proficiency Assessments for California (ELPAC) assessment reports, and the annual Title I night for all parents of targeted students.
- If requested by parents of targeted Title I students, the school provides opportunities for regular meetings at parent-teacher conferences, English Learner Advisory Committee (ELAC), and SSC meetings that allow parents to participate in decisions relating to the education of their students.

School-Parent Compact

CJHS distributes a copy of the school-parent compact to parents of targeted Title I students. The compact has been developed to outline how the parents, the entire school staff, and the students will share the responsibility for the student's improved academic achievement. It describes specific ways the school and families will partner to help targeted students to achieve the state's high academic standards. - The school provides targeted Title I parents with assistance in understanding the state's academic content standards, assessments, and how to monitor and improve the achievement of their students. This occurs through student progress reports, report cards, CAASP reports, ELPAC reports, and School Loop.
- The school provides targeted Title I parents with materials and training to help them work with their students to improve their student's academic achievement. Through regularly scheduled PIQE meetings, parents will receive high-quality training about how to be involved in their student's schooling and achievement.
- Parents will be notified with the CAASP preparatory information in the school's newsletter, automated phone system, and School Loop.
- With the assistance of parents, the school educated staff members about the value of parent contributions and how to work with the parents as partners.
- The CJHS compact incorporates the value of parent involvement along with the school staff, to achieve student improvement. Parent
