## Absences

---

It is very important for a parent/guardian to report their child's absence from school. Please email our attendance clerk at [syung@fusdk12.net](mailto:syung@fusdk12.net) OR call the attendance line at **510-656-3500**, press **7** and press **1** (24 hour absence recorder is available) **before 9:00 A.M.** on **each day the child is absent**. If the school does not receive a phone call or an email, the school will call the parent to verify the absence. If parent contact is not made, the absence will be listed as unexcused. **Please note: After two unexcused absences the student will be considered truant.**

An absence must be reported with either a telephone call or an email, (or a note signed by the parent/guardian when we have in-person classes). Please note that only illness, medical appointment, or bereavement are excused absences. Refer to the FUSD Parent/Guardian & Student Handbook for more about excused absence.

When calling or emailing about an absence, please leave the following information:

- Student's legal full name (**please spell slowly**), student ID number, and grade level
- Reason for the absence
- If it is a partial day absence, please specify the time of absence
- Call back phone number (when calling)
- Person calling or emailing and relationship to the student

Please remember the school and district miss out on Average Daily Attendance funding from the state even with excused absences such as "sick".

This applies to in-person classes:

If the parent/guardian cannot phone or email, the school must have a note explaining the absence. The student can bring a note verifying an absence to the office before school begins on the date of his/her return.

The note should include:

1. The student's legal full name
2. The date of the absence
3. The reason for the absence
4. Parent/guardian's signature

# Distance Learning Parent/Guardian Protocol

## Parent/Guardian Protocols during Distance Learning

As we move into a new full distance learning model this year, it's important for our parents/guardians and their families to understand and respect the legal aspects pertaining to students, teachers, and staff.

### Student Confidentiality

- All students have the right to confidentiality, which extends to distance learning.
  - Exception: By law, staff members are mandated reporters and required to report suspected child abuse, as well as safety concerns related to danger of self and to others.
- To the extent possible, all students should remain in a confidential setting while viewing in-classroom teaching.
- [Per Education Code 51512](#), it is illegal to record teachers and/or students. This is a violation of student and staff privacy.
- In-classroom teaching is for the personal use of the student for the sole purpose of distance learning.
- Parents/guardians and family members of early elementary students may support students as they learn how to use online platforms to access learning.
- We ask that parents/guardians who need to communicate with their student's teacher schedule a meeting with the teacher so that the live instructional time can proceed without interruptions. All teachers have identified office hours to support students and families.

### Academic Integrity

- FUSD places a high value on academic integrity and honesty. Students are expected to use only the resources and references allowed by their teachers in completing assignments and assessments.
- While collaborative work with other students is often encouraged and acceptable, students must follow teacher directions when told to work independently.
- Students who cheat on assignments or assessments will be penalized.

### Student Dress Code and Behavior

- Students should keep to the dress code as they would in a physical classroom, and avoid inappropriate clothes during a live session.
- The District has the right to monitor behavior, identify bullying, and set expectations for good behavior while using these platforms.
- The District may use audio or video recordings when investigating possible inappropriate behavior.

### Visiting the School Site

Our school sites are closed to the public but there may be instances when the site administrator will contact you or students to come to the site. In order to follow health and safety guidelines provided by the Alameda County Public Health Department (ACPHD) and California Department of Public Health (CDPH), we ask that all visitors:

- Maintain a social distance of six feet with anyone around you. In addition, we will only allow a maximum of two visitors at a time in all school offices.
- Wear face coverings at all times. Those without a face covering will not be allowed on any school property.
- Limit their movement on campus to the school office only. Visitors, including parents/guardians, are not allowed to enter the school grounds or classrooms.
- Adhere to the drop off/pick up schedules for packets and assignments as determined and communicated by each school site.

### Best Practices for Students and Staff during Distance Learning

- With an eye towards these privacy issues, we have put together the following shortlist of best practices when using distance learning platforms:
  - Avoid uploading sensitive, confidential, or personally identifiable information to these platforms whenever possible.
  - Always access these platforms from the same device (e.g., designate one computer for distance learning; do not use multiple computers or devices).
  - Regularly clear your internet history, including your browsing history, cache, and cookies.
  - Do not share your login credentials or meeting links with anyone.
  - Use an advertisement blocking program while accessing these platforms.

## 遠程學習期間的家長/監護人協議

隨著今年我們進入一種新的全面遠程學習模式，對於我們的家長/監護人及其家人來說，理解並尊重與學生，老師和教職員工有關的法律方面細則至關重要。

## 學生保密權

- 所有學生都享有保密權，該權利延伸到遠程學習。
  - 例外：根據法律規定，工作人員是授權舉報者，並必須舉報可疑的虐待兒童行為以及與自我和他人危險有關的安全隱患。
- 在觀看課堂教學時，所有學生應盡可能保持機密狀態。
- [根據教育法規51512的規定](#)，錄製老師和/或學生是非法的。這侵犯了學生和工作人員的隱私。
- 課堂教學僅供遠程學習的學生個人使用。
- 低年級小學生的父母/監護人和家庭成員可以在學生學習如何使用在線平台進行學習時為其提供支持。
- 我們要求需要與學生的老師進行溝通的父母/監護人安排與老師的單獨會議，以確保實時教學時間不受干擾。所有老師都有確定的辦公室時間以支持學生和家庭。

## 學術誠信

- FUSD高度重視學術誠信和誠實。學生應僅使用老師允許的資源和參考資料來完成作業和評估。
- 雖然通常鼓勵和接受與其他學生的合作，但是當被告知要獨立工作時，學生必須遵循老師的指導。
- 作業或評估作弊的學生將受到處罰。

## 學生著裝規範和行為

- 學生應該遵守和在實體教室中一樣的著裝要求，並在現場直播中避免穿著不合適的衣服。
- 在使用這些平台時，學區有權監控行為，識別欺凌行為並為良好行為設定期望。
- 在調查潛在的不當行為時，學區可能會使用音頻或視頻記錄。

## 到訪學校現場

我們的學校向公眾關閉，但是在某些情況下，學校管理人員會聯繫閣下或學生進入學校。為了遵守阿拉米達縣公共衛生部（簡稱ACPHD）和加利福尼亞公共衛生部（簡稱CDPH）提供的健康和​​安全指南，我們要求所有訪客：

- 與您周圍的任何人保持六英尺的社交距離。此外，我們所有學校辦公室一次最多只能允許兩名訪客。
- 始終佩戴面罩。那些沒有佩戴面罩的人將不允許進入任何學校所屬物業。
- 將他們在校園內的活動僅限於學校辦公室。訪客，包括家長/監護人，均不得進入校園或教室。
- 遵守每個學校為留下/領取文件包和作業而確定和傳達的時間表。

## 遠程學習中學生和員工的最佳做法

考慮到這些隱私問題，在使用遠程學習平台時，我們匯總了以下最佳做法的清單：

- 盡可能避免將敏感，機密或個人身份信息上傳到這些平台。
- 始終從同一設備訪問這些平台（例如，指定一台計算機進行遠程學習；請勿使用多台計算機或設備）。
- 定期清除您的互聯網歷史記錄，包括瀏覽歷史記錄，緩存和數據(Cookie)。
- 不要與任何人共享您的登錄憑證或會議鏈接。
- 訪問這些平台時，請使用廣告攔截程序。

## Protocolos de Padres/Tutores durante el Aprendizaje a Distancia

A medida que avanzamos hacia un nuevo modelo de aprendizaje a distancia este año, es importante que nuestros padres / tutores y sus familias comprendan y respeten los aspectos legales relacionados con los estudiantes, los maestros y el personal.

### Confidencialidad del estudiante

- All students have the right to confidentiality, which extends to distance learning.
  - Excepción: Por ley, los miembros del personal son informantes obligatorios y están obligados a denunciar sospechas de abuso infantil, así como preocupaciones de seguridad relacionadas con el peligro para sí mismos y para los demás.
- En la medida de lo posible, todos los estudiantes deben permanecer en un entorno confidencial mientras ven la enseñanza en el aula..
- [Según el Código de Educación 51512](#), es ilegal registrar a los maestros y / o estudiantes. Esta es una violación de la privacidad de los estudiantes y el personal.
- La enseñanza en el aula es para uso personal del estudiante con el único propósito de aprendizaje a distancia.
- Los padres / tutores y los miembros de la familia de los primeros estudiantes de primaria pueden apoyar a los estudiantes mientras aprenden a usar las plataformas en línea para acceder al aprendizaje.
- Pedimos que los padres / tutores que necesiten comunicarse con el maestro de su estudiante programen una reunión con el maestro para que el tiempo de instrucción en vivo pueda continuar sin interrupciones. Todos los maestros han identificado horarios de oficina para apoyar a los estudiantes y sus familias.

### Integridad academica

- FUSD valora mucho la integridad y honestidad académicas. Se espera que los estudiantes usen solo los recursos y referencias permitidos por sus maestros para completar tareas y evaluaciones.
- Si bien el trabajo colaborativo con otros estudiantes a menudo se alienta y es aceptable, los estudiantes deben seguir las instrucciones del maestro cuando se les pide que trabajen de forma independiente.
- Los estudiantes que hagan trampa en tareas o evaluaciones serán penalizados.

### Código de vestimenta y comportamiento del estudiante

- Los estudiantes deben respetar el código de vestimenta como lo harían en un aula física y evitar la ropa inapropiada durante una sesión en vivo.
- El Distrito tiene el derecho de monitorear el comportamiento, identificar el acoso escolar y establecer expectativas de buen comportamiento mientras usa estas plataformas.
- El Distrito puede usar grabaciones de audio o video al investigar un posible comportamiento inapropiado.

### Visitando el plantel escolar

Nuestros sitios escolares están cerrados al público, pero puede haber casos en los que el administrador del sitio se comunique con usted o con los estudiantes para que vengan al sitio. Para seguir las pautas de salud y seguridad proporcionadas por el Departamento de Salud Pública del Condado de Alameda (ACPHD) y el Departamento de Salud Pública de California (CDPH), pedimos que todos los visitantes:



- Mantenga una distancia social de seis pies con cualquier persona a su alrededor. Además, solo permitiremos un máximo de dos visitantes a la vez en todas las oficinas de la escuela.
- Use cubiertas faciales en todo momento. Aquellos que no tengan la cara cubierta no podrán entrar en ninguna propiedad escolar.
- Limitar su movimiento en el campus a la oficina de la escuela solamente. Los visitantes, incluidos los padres / tutores, no pueden ingresar a los terrenos de la escuela ni a las aulas.
- Cumplir con los horarios de entrega / recogida de paquetes y asignaciones según lo determinado y comunicado por cada escuela.

### Mejores prácticas para estudiantes y personal durante el aprendizaje a distancia

Con miras a estos problemas de privacidad, hemos recopilado la siguiente lista de mejores prácticas al utilizar plataformas de aprendizaje a distancia:

- Evite cargar información sensible, confidencial o de identificación personal en estas plataformas siempre que sea posible.
- Acceda siempre a estas plataformas desde el mismo dispositivo (por ejemplo, designe una computadora para el aprendizaje a distancia; no utilice varias computadoras o dispositivos).
- Borre regularmente su historial de Internet, incluido su historial de navegación, caché y cookies.
- No comparta sus credenciales de inicio de sesión o enlaces de reuniones con nadie.
- Utilice un programa de bloqueo de publicidad mientras accede a estas plataformas.

## Free Meal Program

---

Child Nutrition Services staff will be on campuses district-wide starting tomorrow, September 3rd. If there are no meals being served at the school site, then the CNS staff will be in the kitchen areas, at their regular shift times. Please note that there will be no operational (serving time/location) changes to the meal program at the 30 school sites currently serving meals- CNS staff will simply be at *all* sites starting tomorrow, and may be visiting kitchens.

The United States Department of Agriculture has issued a waiver that will allow FUSD to serve free breakfast and lunch meals to all children aged 2 to 18 years old. Children need not be present for meal pick up, and will no longer have to give the CNS staff their ID # (as FUSD enrollment is no longer a requirement). This waiver also allows FUSD to serve meals for Saturday and Sunday (these meals will be given out on Fridays, starting September 11th).

# Xfinity Wi-Fi Hotspot Access Opens Nationwide in Response to Coronavirus

Xfinity Wi-Fi hotspots in out-of-home locations will be available for free to anyone who needs them, including non-Xfinity Internet customers, to keep our communities connected with their friends and family.

**What hotspots are included?** Xfinity Wi-Fi hotspots located both indoors and outdoors in places like shopping districts, parks, businesses, and train stations will be open. Hotspots located in customers' homes are not opened to the public.
