V. I-Ready Diagnostic

- A. Ardenwood performed well about 70% at or above grade level for ELA and about 50% at or above grade level in the math.
 - 1. Students in grades 1-3 learn to read and then in grades 4-6 read to learn.
 - 2. The test is administered at the beginning of the year, and the students are getting acclimated to a new classroom/teacher/routine. Some of the students have not been reading for 3 months.
 - 3. Students may do well on the phonological awareness but not as well on the comprehension. Takes endurance.
- B. Next assessment later in the year

- 1. I-Ready is a screener, and the system provides intervention lessons throughout the year.
- 2. Students work on I-Ready customized lessons individually.
- 3. Ardenwood also has an intervention teacher 2.5 days a week to work with small groups.
- 4. Intervention by YFS counselor Parttime counselor under a licensed counselor mentor on campus with a caseload 7 10 students per week at Ardenwood.
- 5. Plus a full-time school site counselor 5 days a week who provides big group presentations impacting most of the Ardenwood students.
- C. The primary focus of SSC ELAC group is to address whether Ardenwood has appropriate interventions.
 - 1. Growth mindset encourages Intervention targeted growth.
 - 2. SPSA goals to move X% of students out of Tier 2 or Tier 3 Red areas within assessed domains is another measure of growth.

VI. Ardenwood Library

- A. Ms. Sayd new librarian tech got the library up and running and put together a book fair too.
- B. \$1800 from the SIFSA plan being used for books from PermaBound.

VII. New Business

- A. Brief mention of traffic safety around our school. Our crossing guard is back!

- C. School breakfast/lunch program: around summertime, the district sends out the free/reduced lunch applications. This determines how many funds will be allocated to Child Nutrition Services at the district.
